### **PROVISIONAL REGISTRATION OF GLOBAL TRAINING COLLEGE SOUTH AFRICA (PTY) LTD AS A PRIVATE COLLEGE**

Thank you for your application for registration of *Global Training College South Africa (Pty) Ltd* as a private college in terms of the *Continuing Education and Training Act, No.16 of 2006* as amended (hereafter referred to as "the CET Act") and the *Regulations for the Registration of Private Further Education and Training Colleges, 2007* (hereafter referred to as "the Regulations").

It is a pleasure to inform you that *Global Training College South Africa (Pty) Ltd* is hereby granted provisional registration as a private college in terms of Section 31(3) of the CET Act and Regulation 12(4) of the Regulations.

Pursuant to Section 37 of the CET Act and Regulation 12(4)(c) of the Regulations, the following conditions are attached to the registration of *Global Training College South Africa (Pty) Ltd*. These conditions may be amended in terms of Section 38, subject to Section 40 of the CET Act:

**1. Legal name and its use**

- 1.1 Pursuant to Regulations 8 and 16(1) of the Regulations, the college is provisionally registered under the legal name: *Global Training College South Africa (Pty) Ltd*.
- 1.2 *Global Training College South Africa (Pty) Ltd* may not provide continuing education and training in any other name except the above.

**2. Certificate of Registration**

- 2.1 The unique registration number of *Global Training College South Africa (Pty) Ltd* is **2018/FE07/048**.
- 2.2 **Certificate No.231** issued in terms of Section 31(4)(c) of the CET Act, certifies that *Global Training College South Africa (Pty) Ltd* is provisionally registered as a private college in terms of Section 31(3) of the CET Act and Regulation 12(4)(b) of the Regulations to offer the part-qualifications listed thereon. The use of the certificate is subject to Section 32 of the CET Act and Regulation 19 of the Regulations.

**3. Duration of provisional registration**

*Global Training College South Africa (Pty) Ltd* is provisionally registered for a period of three (3) years until **31 December 2021**. However, *Global Training College South Africa (Pty) Ltd* is advised that compliance with financial sustainability will be assessed during annual reporting on 30 April 2019, after which its provisional registration shall be reviewed.

**4. Approved site of delivery**

In terms of Regulation 12(5) of the Regulations, the following site of delivery is approved as the site at which *Global Training College South Africa (Pty) Ltd* must offer its registered qualifications:

**Gauteng:** R2 Building Atlas Road, Bonaero Park, Kempton Park. 1619.

**5. Registered Qualifications**

5.1 *Global Training College South Africa (Pty) Ltd* is provisionally registered to offer the following qualifications that are registered on the National Qualifications Framework:

5.2 In this regard, the provisional registration decision is based on the outcome as reflected in the candidacy state of readiness letter of *CATHSETA* dated 23 October 2018.

5.3 *Global Training College South Africa (Pty) Ltd* shall not issue certificates for the registered qualification in 5.1. Such certificates shall be issued by the quality assurance body that granted *Global Training College South Africa (Pty) Ltd* accreditation to offer the registered qualification. The responsibility of *Global Training College South Africa (Pty) Ltd* is to ensure that students do receive their certificates on successful completion of the registered qualification.

5.4 *Global Training College South Africa (Pty) Ltd* may not offer any other part-qualifications and qualifications except for the registered qualification listed in 5.1 above.

**6. Accreditation cycle**

According to the accreditation letter cited in 5.2 above, *Global Training College South Africa (Pty) Ltd's* accreditation expires in 31 March 2020. In order to ensure that *Global Training College South Africa (Pty) Ltd* continues to meet the requirements for registration in terms of Regulation 18(a) of the Regulations, it must secure re-accreditation before the accreditation expiry date.

**7. Official documents, advertising and marketing material**

Regulation 19(b) of the Regulations requires *Global Training College South Africa (Pty) Ltd* to print its provisional registration number on all its letterheads, documents, advertising and marketing materials. Furthermore, it is required to include the expiry date of its registration on all its letterheads, documents, advertising and marketing materials.


**8. Amendment of provisional registration**

Should *Global Training College South Africa (Pty) Ltd* wish to amend any condition of its provisional registration, it must lodge an application for amendment in accordance with Section 35 of the CET Act and Regulation 4 of the Regulations.

In conclusion, *Global Training College South Africa (Pty) Ltd's* certificate of provisional registration referred to in 2 above, as well as the original copy of this letter will be sent to you by registered mail.
